  - For a student within Landscape Architecture: the production of landscape representations using two or three-dimensional mixed media spanning drawn, modelled, programmed, recorded or filmed processes.

## EDUR136/EDUR138 DOCTOR OF EDUCATIONAL AND CHILD PSYCHOLOGY (DEdCPsy) (Full-Time)

### This programme of study is non-modular.

1. A person may be admitted as a student who has a degree in Psychology and is eligible for the Graduate Basis for Chartered Membership (GBC) of the British Psychological Society. Relevant experience of working with children and/or young people via employment with a Local Authority or employer deemed to be equivalent is also a pre-requisite to

admission.

2. The programme of study will be pursued for not less than three years. Supervised practice in Educational Psychology on placement will be for a period comprising not less than *three hundred days* in line with PSRB requirements.
 

**(For students commencing the programme of study and research before 1 August 2022)** The time limit for completion of the programme will be three years.

**(For students commencing the programme of study and research on or after 1 August 2022)** The time limit for completion of the programme will be four years.
3. A student will take
  - (a) prescribed coursework, including evaluative projects, case studies and critical papers on a range of relevant topics;
  - (b) supervised practice in educational psychology on placement which is evidenced through the production of placement files;
  - (c) a thesis.
4. The examination will consist of
  - (a) an evaluative project;
  - (b) a reflective case study;
  - (c) critical papers;
  - (d) placement files;
  - (e) assessment of clinical competence on placement;
  - (f) a thesis;
  - (g) an oral examination in matters relevant to the subject of the thesis.
5. A student will pursue a programme of research in accordance with the General Regulations for Higher Degrees. The thesis will be submitted by a date prescribed by the Head of Department in the final year of the course. A student may re-submit the thesis on one occasion only within twelve months of the original submission date.
6. A student who fails to satisfy the examiners in any part of the assessments may be permitted to retake that element on one further occasion.
7. A student must pass all components of Year 1, including the placement file submission, in order to proceed to Year 2 of the programme and the Year 2 placement. A student must pass all components of Year 2, including the placement file submission, in order to proceed to Year 3 of the programme and the Year 3 placement.
8. In the event of failure of a fieldwork placement, a student will be required either to repeat the placement successfully or undertake successfully an alternative placement. In the event of failure of a repeat placement or any two placements over the duration of the course, a student will be excluded from the programme. All competencies by the end of year 3 need to be demonstrated (see Regulation 3b).
9. A student who has successfully completed all academic and research components of Year One of the course, despite failing the fieldwork placement component may be awarded the Master of Arts in Education and Child Psychology. They would not under any of these circumstances be professionally qualified educational psychologists or be able to practice as such.
10. A student who contravenes the Code of Conduct for Psychologists or the Guidelines for Professional Practice of Educational Psychology of the British Psychological Society may be dealt with under General Regulations as to the Progress of Students, the General Regulations relating to Student Fitness to Practise or the General Regulations as to the Discipline of Students.
11. Further to the General Regulations for Higher Degrees by Research, students will meet the requirements of the DDP via provision within the programme's taught modules and supervisory meetings. This will comprise an equivalent scheme of activities requiring students to engage in a reflective process, attain the core competencies, and evidence

their development. However, they will not be required to undertake:

- (i) a Training Needs Analysis (TNA) or development plan;
- (ii) separate modules at either Faculty or departmental level which students are ordinarily required to complete as part of the DDP (with the exception of Research Ethics and Integrity, which students are required to take);
- (iii) an Evidencing Development Summary.

Students will complete the compulsory Research Ethics and Integrity module, as approved by the Faculty.

## **EDUR161 DOCTOR OF EDUCATION (Language Learning and Teaching) (EdD) (Distance Learning)**

### **For students whose initial registration is prior to 2020/21.**

1. A person may be admitted as a student in one of the following categories
  - part-time student candidate
  - staff candidate
2. The programme of study will be pursued for not less than four years and not more than eight years. The time limit of Part I of the programme will be four years. The time limit for the presentation of the thesis will be four years from the commencement of Part II.
3. During Part I of the programme a student will take

4. During Part II of the programme, a student will pursue a programme of research in accordance with the General Regulations for Higher Degrees by Research, and will present a thesis in accordance with those Regulations. A student must complete Part I of the programme satisfactorily before proceeding to Part II. This may involve a requirement to successfully undertake a viva voce at the end of Part I if this is deemed to be necessary by the Head of Department.
5. A student must pass four or more of the six units listed at 3 above at the first attempt in order to proceed to Part II of the programme. The Head of Department may require a student who has not satisfied this requirement to become instead a student for the MA in Educational Studies.
6. A student who has been awarded *one hundred and eighty* credits in respect of the units listed at 3 above and
  - (a) does not proceed to Part II of the programme, *or*
  - (b) fails the thesis
 will be eligible for the award of the Degree of MA in Educational Studies.

 Students will engage with equivalent Research Ethics and

Integrity provision, as approved by the Faculty.

## **Sheffield Methods Institute (SMI) Postgraduate Regulations**

### **ACRS94/SMIR01 Data Analytics and Society (PhD with Integrated MSc) (Full-Time) (CDT)**

1. A person may be admitted as a candidate in the following category:
  - a) full-time student candidate.
2. A student will be required to undertake a programme of taught study as defined in the Regulations for SMIT03.
3. In order to progress to the second year of study, a student must successfully complete the requirements of the first year of registration, to include:
  - a) obtaining a total of not less than 90 of the integrated Master's Degree element;
  - b) full engagement in other aspects of the programme (e.g. regular attendance at journal clubs and away days, internship module etc.).
4. A student who is awarded 60 credits (as per the regulations for SMIT05) but who does not wish to proceed to the second year of study, or who does not successfully complete the requirements of the first year of study, may be awarded an approved Postgraduate Certificate in Data Analytics and Society.
5. In order to progress to the third year of study, a student must successfully complete the requirements of the second year of registration, to include:
  - a) obtaining a total of not less than 165 credits of the integrated Master's Degree element;
  - b) submission of a research project that has been approved by the programme directors;
  - c) full engagement in other aspects of the programme (e.g. regular attendance at journal clubs and away days, etc.).
6. A student who is awarded 120 credits (as per the regulations for SMIT04) and/or has produced sufficient research evidence but who does not wish to proceed to the third year of study, or who does not successfully complete the requirements of the second year of study, may be awarded an approved Postgraduate Diploma in Data Analytics and Society and / or be permitted to transfer candidacy for the Degree of MPhil. Should the student obtain both awards, they will be made in an integrated form.
7. A student who fails to satisfy the Examiners in respect of a credit-bearing unit may enter for a subsequent examination in respect of the unit on one occasion only.
8. A student's registration for the Degree of PhD will be considered probationary until such time as the candidate successfully passes the departmental Confirmation Review. A student may be permitted a maximum of two attempts to pass the Confirmation Review. The first attempt must be completed no later than 2 years from the student's initial date of registration. The final decision regarding whether a student may be permitted to pass the Confirmation Review must be taken within 2.5 years of the student's initial registration. A student who fails the Confirmation Review will be required to transfer to candidacy for the Degree of MPhil.
9. In all other aspects of the programme, the Regulations for the Degree of PhD in all Faculties will apply.

## **School of Law Postgraduate Regulations**

### **Regulations for the Degree of Master of Laws by Research (LLM)**

#### **LAWR151 LAW (LLM) (Full-Time)**

#### **LAWR161 LAW (LLM) (Part-Time)**

1. A person may be admitted as a student who has a 2:1 undergraduate degree in Law or a cognate subject
2. A student will pursue a programme of research in a branch of Law and on the completion of the programme of research present a thesis of 40,000 words containing the results of the research. An oral examination may also be required, at the discretion of the examiners.
3. The time-limit for the presentation of the thesis will be two years for a full-time student, and four years for a part-time student.
4. Subject to the above Regulations, the Regulations for the Degree of MPhil will apply in respect of students for the Degree of LLM.
